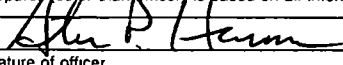

THROUGH THE TITLE X PROGRAM, REPRODUCTIVE HEALTHCARE SERVICES ARE PROVIDED TO WOMEN, MEN, AND ADOLESCENTS IN IOWA. IN ADDITION TO CLINICAL SERVICES, TITLE X FOCUSES ON COMMUNITY EDUCATION, OUTREACH, AND FAMILY INVOLVEMENT. THESE EFFORTS OCCUR AT THE STATE AND LOCAL LEVEL TO MAKE THE PUBLIC AWARE OF FAMILY PLANNING SERVICES AS A PART OF AN OVERALL HEALTH PROMOTION AND DISEASE PREVENTION STRATEGY.
