FOR MORE THAN 85 YEARS, BROADLAWNS MEDICAL CENTER (BMC) HAS ENHANCED THE QUALITY OF LIFE FOR RESIDENTS THROUGH HEALING, TEACHING AND CARING. MUCH OF THIS CARE IS POSSIBLE ONLY THROUGH THE GENEROSITY OF OTHERS. POLK COUNTY RESIDENTS FROM ALL WALKS OF LIFE MAY FIND THEMSELVES WITHOUT ADEQUATE HEALTH INSURANCE COVERAGE AT ONE TIME OR ANOTHER. MANY OF THE PATIENTS WHO ARE SEEN AT BMC HAVE NO COVERAGE OR INADEQUATE COVERAGE. AS A RESULT, IF IT WERE NOT FOR THE COMPASSION AND COMMITMENT OF BMC AND BROADLAWNS MEDICAL CENTER FOUNDATION (BMCF), THESE NEIGHBORS WOULD NOT HAVE ACCESS TO THE HEALTH CARE THEY NEED. THE BROADLAWNS MEDICAL CENTER FOUNDATION SUPPORTS THE MISSION OF BMC. THIS SUPPORT ALLOWS BMC TO CONTINUE DELIVERING THE HIGH QUALITY OF CHARITABLE CARE THAT IS PROVIDED FOR THOSE IN OUR COMMUNITY WHO DO NOT HAVE THE FINANCIAL RESOURCES TO COVER THEIR HEALTH CARE EXPENSES. GIFTS TO BMCF ALSO PROVIDE NEEDED RESOURCES TO IMPROVE BMC FACILITIES, REPLACE AGING MEDICAL EQUIPMENT AND ACQUIRE STATE-OF-THE-ART TECHNOLOGY. OVER THE YEARS, BMCF HAS HELPED BMC ACQUIRE NEW SURGICAL EQUIPMENT, CHILD-THEMED PEDIATRIC EXAM TABLES, BIRTHING BEDS, WHEELCHAIRS, DENTAL EQUIPMENT, MAMMOGRAM TECHNOLOGY, NEW TECHNOLOGY FOR THE BIRTHING CENTER AND MORE. CURRENT YEAR FUNDS WERE USED TO PROMOTE THE NEEDS OF THE MEDICAL CENTER BY FUNDRAISING AND DISTRIBUTING FUNDS FOR THE HOSPITAL PROGRAMS AND EQUIPMENT. THIS MONEY IS RAISED THROUGH INDIVIDUAL AND CORPORATE DONATIONS, FOUNDATION AND GRANTS AND IN-KIND CONTRIBUTIONS. THE REVENUE COLLECTED WAS USED TO SUPPORT THE FOLLOWING NEEDS AT BROADLAWNS MEDICAL CENTER: FOCUS - SCHOOL PROGRAM TO ASSIST KIDS NEEDING MENTAL HEALTH COUNSELING, CONSTRUCTION FOR THE PEDIATRIC CLINIC, BMC CLOTHING CLOSET, MEDICATION ASSISTANCE FOR PATIENTS IN NEED, MAMMOGRAMS FOR PATIENTS IN NEED, LANDSCAPING AROUND THE HELIPORT AREA, X-RAY APRONS AND APRON RACKS FOR FOOT & ANKLE CLINIC, REMODELING OF HOSPITAL MAIN ENTRANCE, PEDIATRIC CLINIC EXAM TABLES, CLOSED CIRCUIT EQUIPMENT FOR TV EDUCATIONAL CHANNELS, DIGITAL MAMMOGRAPHY EQUIPMENT, OTHER HOSPITAL NEEDS INCLUDING FURNITURE, CARPET, ARTWORK, ETC.
