Pi Beta Phi Foundation funds a broad array of programs designed to benefit the Fraternity, its members and the community at large - Leadership programming educates undergraduate women and develops the next generation of leaders to combat illiteracy, so that we can have a greater impact on our communities \$422,860 in support for these important programs, serving more than 14,000 undergraduates, was made possible in FY11-12 - Scholarships assist women in undergraduate and graduate school programs, as well as alumnae continuing education awards. More than 120 awards totaling \$230,200 were made in FY11-12 - Specific philanthropic programs assist individuals in dire financial distress, support the heritage and history of Holt House and Arrowmont School of Arts & Crafts, provide assistance for educational area grant programs for specific chapter housing, and provide essential support for Pi Phi's literacy efforts, including Champions Are Readers, Arrow in the Arctic, and First Book. Literally tens of thousands of children were assisted through Pi Phi's literacy efforts in FY11-12. In total, \$371,316 was granted to specific philanthropic priorities in FY11-12.
