During the period of January 1, 2012 through June 30, 2012, First Hand changed the lives of 521 children around the world by provided funding for travel and lodging related to medical care, bilateral hearing aids, cochlear implants, cranial helmets, transplants, surgeries, medications, therapies (speech, occupational, hippo, vision, aquatic, and physical), formula, wheelchairs, adaptive equipment, van lifts, dental care and glasses. The average grant is \$2,048.
