Funds are received through workplace giving campaigns, individuals, businesses, municipalities and civic organizations that are then annually re-granted. More than \$2.9 million funds have been raised since 2007, the first year of this initiative.

Business Programs Provide resources and information to area businesses to help these companies deepen their connections with the local arts community, form meaningful partnerships and provide their employees with the opportunities to express creative and innovation skills that will improve business practices.

Raise awareness and support for the Arts. Participate in meetings and conferences in which the value and economic benefit that the Arts bring to the community can be expressed. Provide meetings and outreach opportunities to individuals and arts organizations that will promote the Kansas City region as America's Creative Crossroads. Advocate for additional and continued funding for increased impact on the Community by the Arts. More than 60 arts organizations participated or were served through various programs sponsored by the Arts Council. More than 3,000 individuals have advocated and supported continued funding of the Arts. The Arts Council coordinated the Americans for the Arts Local Arts Index data tabulation for the Kansas City region, providing critical data for the development of a regional cultural plan. This data also helped validate the fact that the Arts are an economic engine for the area.
