Junior Achievement (JA) programs help prepare young people for the real world by showing them how to generate wealth and effectively manage it, how to create jobs which make their communities more robust, and how to apply entrepreneurial thinking to the workplace. Engaging themes help K-5 students learn economic concepts through the Elementary School Program. Each theme builds on the previous and stresses the relationship between school and future success. The Middle Grades Program emphasizes the importance of an education and staying in school while introducing students to economic concepts and information about the world of work, financial literacy, and entrepreneurship. The High School Program strives to help students develop the knowledge, skills, and attitudes necessary to become productive citizens and workers. JA reached 19,210 students through 613 classes taught by 560 volunteers. Through these classes, students received 78,836 contact hours of instruction that meets the common core educational standards recognized in Kansas and Missouri. Additional volunteers helped raise money for JA through the Bowl-a-Thon, the Greater Kansas City Business Hall of Fame, and Calls for Kids Campaign. ASE Group, Inc. contributed \$15,000 in services to towards the Business Hall of Fame.
