FOR THE PAST 16 YEARS, THE MEDCENTER ONE FOUNDATION HAS PARTNERED WITH THE MEDCENTER ONE REHABILITATION DEPARTMENT TO PLAN AND IMPLEMENT THE GREAT AMERICAN (STATIONARY) BIKE RACE BENEFITING CHILDREN AFFLICTED WITH CEREBRAL PALSY OR RELATED DISORDERS. THIS BIKE RACE, HELD EACH APRIL, HAS GROWN TO BECOME THE LARGEST FUNDRAISER OF ITS KIND IN THE UNITED STATES, GENERATING OVER \$1.04 MILLION IN GROSS INCOME FOR THE PAST FOUR YEARS ALONE AND OVER \$1.8 MILLION OVER THE LAST 16 YEARS. AMBER DESROCHES WAS JUST 15 YEARS OLD WHEN LEUKEMIA TOOK HER LIFE IN THE DAYS PRECEDING CHRISTMAS, 2007. IN TIME, AND DESPITE UNBEARABLE GRIEF AND SORROW, AMBER'S FAMILY COULDN'T HELP BUT REMEMBER HOW THE TEENAGER OFTEN TALKED ABOUT TRANSFORMING THE CHILDREN'S HOSPITAL HERE AT MEDCENTER ONE. WHEN SHE WASN'T TELLING SOMEONE WHAT SHE ENVISIONED FOR THE CHILDREN WHO WOULD BE HOSPITALIZED AFTER HER, SHE PENCILED HER THOUGHTS IN HER JOURNAL. AMBER ENVISIONED A CHILDREN'S HOSPITAL WHERE EVERYTHING WAS POSSIBLE AND NOTHING WAS IMPOSSIBLE. AMBER WANTED SICK AND INJURED CHILDREN TO
