These services take the form of initial housing, furniture, clothing, household goods, food, placement of children in school, introduction to community service providers, medical referral and extensive case-management services.

4b (Code: 624100) (Expenses \$ 86,664 including grants of \$ 2,643) (Revenue \$ 124,149)

Prison and Jail Ministry: Staff provides assistance to those incarcerated in the form of education, community re-entry, training, religious materials, and retreat experiences. Services are provided to nine correctional facilities by Catholic Charities of Central and Northern Missouri staff, Catholic clergy, and a volunteer staff of 40 religious and lay persons.

Poverty Outreach and Community Assistance: Staff provide referrals to direct service providers and community based poverty-relief agencies that provide food, shelter, utilities assistance, health care, or vital assistance to needy children, individuals, and families. Additionally, staff distributes funds to individuals and families through St. Vincent De Paul charitable outreach activities to assist those individuals in need of immediate emergency aid.
