I. BACKGROUND

The DeKalb Community Service Board (“DeKalb CSB”) formed BSCD Properties, Inc. for the primary purpose of soliciting, receiving, and maintaining monetary contributions and/or real or personal property to use and apply for the exclusive benefit of DeKalb CSB.

DeKalb CSB is a statutorily-created public nonprofit corporation and agency that offers a full range of mental health and substance abuse treatment services and developmental disability programs. See O.C.G.A. Title 37, Chapter 2. DeKalb CSB operates in over twenty (20) locations in DeKalb County, Georgia, including four outpatient clinics, the DeKalb Regional Crisis Center, the DeKalb Addiction Clinic, the DeKalb MR Services Center, and DeKalb Enterprises. In 2010, DeKalb CSB served 11,712 consumers, sixty percent (60%) of whom were uninsured. Five hundred dedicated and qualified staff members represent DeKalb CSB including social service providers, service coordinators, behavioral specialists, registered nurses, physicians, psychiatrists, psychologists and administrative support. DeKalb CSB charges for services based on income and family size. The agency receives funding from the Georgia Department of Behavioral Health and Developmental Disabilities, DeKalb County, and private donors. Yet, over the past eight years, state funding for services in DeKalb CSB has declined by over thirty-six (36) percent.

As a public agency, the Board of Directors of DeKalb CSB is determined in accordance with O.C.G.A. § 37-2-6(e)(1) and O.C.G.A § 31-3-2. Accordingly, the Board of Directors of BSCD Properties is comprised entirely of directors of DeKalb CSB. No BSCD Properties’ directors or officers will be compensated by DeKalb CSB or BSCD Properties; rather, the officers and directors of DeKalb CSB provide assistance to BSCD Properties in the form of “in kind” contributions.

II. ACTIVITIES

The following activities further BSCD Properties’ exempt and charitable purposes:

1. DeKalb Addiction Clinic

BSCD Properties will own the DeKalb Addiction Clinic building. This building is operated by and used exclusively by DeKalb CSB for comprehensive and intensive outpatient substance abuse treatment services addressing the social, psychological, physical and spiritual components of recovery through education, counseling, coping skills and life skills development. DeKalb CSB will remain the administrator of, and employ the staff for the various programs offered at the Clinic.

2. Group Homes for the Developmentally Disabled

BSCD Properties will own a number of single-family residential homes for the developmentally disabled. DeKalb CSB will remain the administrator and operator of, and employ the staff for these group homes.

BSCD Properties will devote a hundred percent (100%) of its total time to the activities outlined above. Activities shall be funded by rents collected sufficient to maintain the properties for their charitable purposes.

In March, 2012, residential properties and cash were donated to BSCD Properties, Inc. from not-for-profit entities, as follows:

- DeKalb MR Auxiliary, Inc. donated four (4) single-family residences with total appraised value of \$681,100 plus \$77,105 cash.
- Christian Association for the Retarded, Inc. donated one (1) single-family residence with appraised value of \$133,000.

The aforementioned not-for-profit organizations had owned and operated the homes for the benefit of DeKalb Community Service Board for a number of years.
