The one day event included 85 vendor booths, and informational speakers. Information provided pertained to agricultural marketing and economic trends 2) A golf/networking event which included 160 area producers and sales representatives. Educational displays were used to provide information regarding soybeans 3) The Soybean Leader magazine is a publication which SDSA distributes to the South Dakota soybean producers. Approximately 1,800 copies of the publication were sent out 6 times during the year. Articles included new uses for soybeans, trends, research, disease, and other information regarding soybeans.
