AS WITH ALL THE HOMES IT BUILDS, BHAFH SOLD THE HOMES TO LOW-INCOME FAMILIES WHO CURRENTLY LIVE IN TEMPORARY OR SUBSTANDARD ACCOMMODATION AND DO NOT HAVE ACCESS TO TRADITIONAL SOURCES OF HOME FINANCING.
