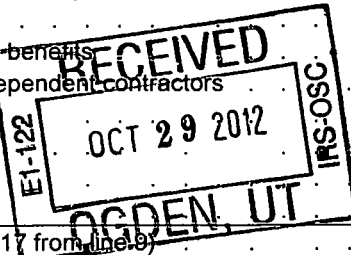

The mission of the Augustinian Scholarship Fund is to provide disadvantaged students access to education and support for academic success so that they can create a promising future for themselves and the community in which they live.

The Augustinian Scholarship Fund serves at least 70 needy students in grades six through the University level. Students must demonstrate economic need, provide evidence of good grades, and live in the communities of La Gloria, Tecolote, Leandro Valle, Lagunitas, Genaro Vargas, and El Ejido in the city of Tijuana, Mexico. Students attend monthly meetings where community-building activities take place. Students are required to participate in service projects. Work-study and volunteer activities are available to the students as well. Educational programs available through ASF include field trips, leadership training, and educational forums with the student's parents and trained facilitators. Field trips expose the students to resources and opportunities which the greater Tijuana area has to offer. Leadership training provides students training in topics such as public speaking, resume preparation, and preparing for interviews. The educational forums include pertinent topics such as communications between parent and child and self-esteem issues. 70 students were helped this year with an average of \$526 each.
