The Good News Broadcasting Association, Inc. is a user-driven provider of life change, generated by researching, developing and distributing Bible engagement tools that help people take a daily, positive step forward in their lifelong spiritual journey. Bible teaching and engagement methodologies include traditional terrestrial broadcasting through radio, podcasts, cellular technology, SMS text messaging, print, Internet and person-to-person sharing through the latest social media technology. The non-profit purposes of The Good News Broadcasting Association span the United States, with media outlets in every state and an international reach through 11 locations across the world. Through all of the variety of the ministry's delivery channels, the single focus of the organization is to walk with people daily into a living, growing and passionate relationship with Jesus Christ.

Radio ProgramBack to the Bible is a 25-minute radio program where listeners and viewers become part of a personal Bible study with Dr. Woodrow Kroll as the leader. Each weekday, Dr. Kroll helps listeners and viewers get a solid grasp of biblical principles and to find ways to apply them to real life. The program was aired on an average of 800 terrestrial radio outlets across the U.S. during the fiscal year. A 28-minute television version is provided through the Web and on select television outlets. The Bible Minute provides biblical insight for everyday life. Each Bible Minute topic has an accompanying Bible Study, giving participants an opportunity to engage God's Word in a meaningful, practical way. Primary distribution is radio with e-mail and RSS formats available at BibleMinute.org. Literature and Media ProductsCDs, DVDs, and printed studies and devotionals provide Bible teaching and engagement items for sale or at no direct cost to individuals around the world. Over 700,000 items helped people win the day spiritually just in the U.S. InternetThe Web sites provided additional materials for those involved in the various audio and video ministries of The Good News Broadcasting Association, Inc. Over 1.0 million unique visitors made use of sponsored Web sites last year.

International MinistriesBack to the Bible International communicates the Word of God in ways that are clear, culturally appropriate and readily understood. Through 10 global locations, listeners and viewers in 85 countries have the opportunity to receive Bible teaching, discipleship and Gospel outreach in a language that is meaningful to them.

Next Generation OutreachPowered by 4 coaches, users through daily Bible engagement. Personal blogs and other resources are used to encourage site visitors to take in God's Word. Research with over 85,000 participants across the U.S. and other international locations proves that engaging with God through His Word four or more times per week provides a distinct power for living. Back to the Bible, through its Center for Bible Engagement, has tested and refined daily spiritual growth methodologies. A genuine breakthrough called goTandem helps seekers and believers connect with and apply God's Word to real life using technology already integrated into their daily lives: cell phones, texting, email and the like. The goTandem methodologies allow disconnected individuals to connect with God through His Word. A 5-year longitudinal study shows 53% of those coming into goTandem with no intention to start engaging Scripture regularly become engaged at least 4 or more days per week. In addition, 75% of those using components of goTandem report they've grown spiritually and are now engaged with the Bible 4 or more days per week. Finally, research concludes that Christians who engage the Bible most days of the week are 228% more likely to share their faith, 231% more likely to disciple others and 407% more likely to memorize Scripture. As of June 30, 2012, nearly 15,700 subscribers were being disciplined daily through goTandem.
