Board members who identify a conflict of interest on any issue are excused from the board meeting while discussion, deliberation and voting takes place on any issue identified as creating a conflict of interest. The Executive Director and other members of the board jointly carry out the responsibility of identifying potential conflicts and ensuring compliance with the bylaws and statutes.
