31 women received free pregnancy counseling services.

36 young women participated in the Teen Moms program.

92 couples inquired about adoption, with 36 couples starting the adoption program, 6 couples completing an adoption workshop series, and 3 children being placed with new parents.

17 people received assistance to locate adoptive family members.

75 healthcare professionals received training about adoption as an

Family strengthening programs provide relationship and marriage education classes to help individuals and couples learn relationship-building skills that benefit both themselves and others. Also, counseling for addiction or relapse prevention helps individuals and families develop habits and behaviors for happier success in all areas of life.

"Love Letters from Kansas", a public awareness campaign, was initiated by Catholic Charities of Kansas to promote free relationship education workshops and services across Kansas.

91 people participated in marriage education classes.

77 people participated in relationship education classes.

63 people received counseling for addiction and relapse prevention.

Family sustaining programs strive to connect individuals and families with resources such as housing, utilities, food, and other essential supplies to meet their basic needs.

24 families out of 36 applicants were helped to secure decent housing through the Homeless Prevention and Rapid Rehousing Program.
