Demand Response Services: Public Transportation to the General Public through Kansas Department of Transportation under the Federal Act 49 U.S.C 5311 (CFRDA 20.509) funded through the Federal Transit Administration and the State of Kansas. Provide services in rural and small urban regions for transportation services provided to the general public. These services include regional transportation services to outlying areas outside Riley County into Geary County, Pottawatomie County and Fort Riley.

Saferide: The Agency has a contractual arrangement with Kansas State University to provide transportation to Students. The mission and purpose of the University program is to save lives and prevent injuries and damage to property by offering students and their guests a safe alternative to drunken driving and other threatening situations. The program runs from Thursday - Saturday from 11 pm to 3 am when the University and classes are in session.

Fixed Route Services: In February 2012, the Agency began to provide their first Fixed-route service, and began contracting with Kansas State University for a route from Jardine housing to campus. In April 2012, the Agency added two additional routes to the fixed-route services to service the City of Manhattan residents. These services are funded through the same sources as Demand Response services, through Kansas Department of Transportation under the Federal Act 49 U.S.C 5311 (CFRDA 20.509) funded through the Federal Transit Administration and the State of Kansas.
