The following Restated and Amended Articles of Incorporation, duly adopted under the authority and provisions of K.S.A. 17-6605 by a majority of the members of the Board of Trustees of the Corporation, and in accordance with the provisions of K.S.A. 17-6602(c)(3) supersede and take the place of the existing articles of incorporation of Hutchinson Regional Medical Center Foundation, formerly Promise Regional Medical Center - Hutchinson Foundation, formerly Hutchinson Hospital Foundation; a Corporation NOT FOR PROFIT organized under the laws of the State of Kansas, originally filed with the Kansas Secretary of State on April 25, 1979, and amendments to the articles as follows:

**FIRST:** The name of the Corporation is:

**HUTCHINSON REGIONAL MEDICAL FOUNDATION**

**SECOND:** The location of its registered office in the State of Kansas is:

Hutchinson, Kansas 67502

**THIRD:** The name and address of its Resident Agent in the State of Kansas is:

1701 East 23rd Avenue  
Hutchinson, Kansas 67502

**FOURTH:** The Corporation is organized NOT for profit and the objects or purposes to be transacted and carried on shall NOT be transacted and carried on for profit, but the Corporation is organized exclusively for charitable, public health, scientific and educational purposes and the funds and property of the Corporation shall at all times be used, handled, administered, operated and distributed by the Corporation exclusively for the benefit of and to carry out such purposes. In order to accomplish the purposes, and to attain the objects for which this Corporation is formed and for which the funds and property of the Corporation shall be used, handled, administered, operated and distributed, as hereinafter set forth, the

Corporation shall possess and exercise all powers, authorities and privileges granted to corporations by the laws of Kansas and, in addition, shall have the following powers, authorities and privileges:

(1) To receive, hold, use, invest and distribute funds, property, real and personal, and income, from individuals, estates, fiduciaries, trusts, and entities of all kinds whatsoever, including, but not limited to, the Maud Collingwood Trust Estate, all for the benefit of and support of Hutchinson Regional Medical Center, Inc., a Kansas NOT for profit corporation which is exempt from U. S. Income Taxes under 501(c)(3) of the U. S. Internal Revenue Code and which has been ruled not a private foundation by reason of the fact that it is an organization described in section 170(b)(1)(A)(iii) of the U. S. Internal Revenue Code.

(2) To receive, lease, manage, take and hold real and personal property, in or outside the State of Kansas by purchase, exchange, lease, gift, devise or bequest and to convey, sell, exchange, lease, assign, transfer, improve, reinvest and otherwise deal in and with all of the property held by the Corporation, and all additions thereto, if in the discretion of the Board of Trustees, it be determined most appropriate to promote and accomplish the purposes of the Corporation.

(3) To invest any money which it may have at any time in such bonds, stocks, funds, common trust funds, notes, real estate, mortgages or other securities, or in such other property, real or personal, as the Board of Trustees shall deem proper.

(4) To hold all shares of stock and other securities belonging to it at any time in its own name, or in the name of any nominee of the Corporation; to vote any of its shares of stock through any of its duly authorized officers, or by proxy; to assent to or waive any stockholders' right or privilege in respect thereof, including any right or privilege to subscribe for or otherwise acquire any additional stock; to assent to any merger, consolidation or reorganization of any property, corporation or other enterprise in which this corporation may be interested, or whose obligations or securities may be held by this Corporation, and to join therein and exchange the securities held by it for such other securities as may be issued pursuant to such action or arrangement; to unite with other owners of similar properties or securities in any plan, agreement or deposit, designed to effectuate any such purpose, and to pay all assessments, or expenses, incidental thereto, and to consent to any lease or other corporate act.

(5) In general to have and exercise all powers conferred upon non-profit corporations by the laws of the State of Kansas, now or hereafter in effect, for the accomplishment of the purposes and the carrying on and promotion of the business and objects of this Corporation, subject, however, to the limitations of Sections 503 and 504 of the U. S. Internal Revenue Code and applicable regulations as the same now exist or may be hereafter emended.

(6) Notwithstanding anything herein to the contrary, the Corporation shall exercise only such powers as are in furtherance of and consistent with the exempt purposes of organizations set forth in Section 501(c)(3) of the U.S. Internal Revenue

Code and its Regulations as the same now exist or as they may be hereafter amended from time to time.

**FIFTH:** No part of the net earnings of the Corporation shall inure to the benefit of any private shareholder or individual. In the event of the liquidation or dissolution of the Corporation, whether voluntary or involuntary, no individual shall be entitled to any distribution or division of its remaining property or its proceeds, and the balance of all money and other property received by the Corporation from any sources, after the payment of all debts and obligations of the Corporation, shall be distributed to Hutchinson Regional Medical Center, Inc., a Kansas non-profit corporation with its principal place of business at 1701 East 23rd Street, Hutchinson, Reno County, Kansas, if such corporation be in existence and operating as Hutchinson Regional Medical Center, Inc. at said location at the time, or to any successor corporation, as the case may be, owning and operating said Hutchinson Regional Medical Center, Inc. facility at said stated address as a non-profit health care facility, or, in the event that at such time there shall be no such non-profit health care facility at said location, or a substitute location, then, in such event, to one or more organizations organized and operated exclusively for charitable, scientific, public health and educational purposes within the meaning of Section 501(c)(3) of the U.S. Internal Revenue Code and its Regulations, as the same now exist or as they may be hereafter amended from time to time, as the Board of Trustees of this Corporation shall determine. Any such assets not so distributed by the Board of Trustees shall be distributed pursuant to an order made by the District Court of Reno County, Kansas, to another organization or organizations, to be used exclusively for charitable, scientific, public health and educational purposes within the meaning of the aforesaid provisions of the U. S. Internal Revenue Code.

**SIXTH:** The Corporation shall NOT have the authority to issue capital stock.

**SEVENTH:** This Corporation is incorporated for a perpetual existence without limitation as to number of years.

**EIGHTH:** The Corporation and its business affairs shall be managed and governed by a Board of Trustees consisting of at least three (3) members, but not more than fifteen (15) members, the exact number thereof to be fixed from time to time by resolution of the Board of Trustees. In the Board of Trustees there shall be vested all of the power and authority to supervise, control, direct and manage the property, affairs and activities of the Corporation. The rights, powers and privileges of the Trustees shall be fixed in the By-Laws.

**NINTH:** There shall be no personal liability of a Trustee to the Corporation for monetary damages for breach of fiduciary duty as a Trustee, provided, however, that this provision shall not eliminate or limit the liability of a Trustee for (a) any breach of the Trustee's duty of loyalty to the Corporation, (b) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, or (c) for any transaction from which the Trustee derived an improper personal benefit.
