THIS PROGRAM PROVIDES BUDGETING AND LIFE-SKILLS WORKSHOPS, EMPLOYMENT ASSISTANCE, TRANSPORTATION, DAYCARE, AND REFERRAL SERVICES FOR MENTAL HEALTH, HEALTH, AND SUBSTANCE ABUSE TREATMENT. THE ORGANIZATION HAS ANOTHER HUD GRANT TO PROVIDE PERMANENT HOUSING FOR SEVEN DISABLED INDIVIDUALS WHO HAVE MET THE HUD DEFINITION FOR CHRONIC HOMELESSNESS.
