EMERGENCY SHELTER - SINCE 1989, THE LIGHT HOUSE HAS OPERATED AN EMERGENCY SHELTER IN 2010 OPENED A NEW 24,000 SQUARE FOOT RESIDENTIAL LIVING FACILITY. THE CUSTOM-DESIGNED FACILITY HOUSES 15 WOMEN, 30 MEN AND FIVE FAMILIES WITH UP TO 20 CHILDREN ON AN EMERGENCY BASIS. FOOD AND SHELTER ARE PROVIDED ALONG WITH ONSITE SUPPORTIVE SERVICES INCLUDING CASE MANAGEMENT, GED CLASSES, COMPUTER TRAINING, EMPOWERMENT AND PARENTING CLASSES, ART CLASSES, ADDICTIONS COUNSELING, AS WELL AS HOUSING AND JOB SEARCH SUPPORT.
