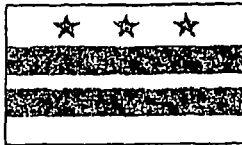
Community Impact:

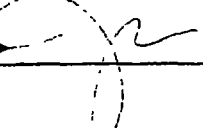
