Emory & Henry College provided formal instruction and related academic support for 864 full-time equivalent students toward the fulfillment of Bachelor of Science and Bachelor of Art degrees in over 50 fields of study. Student financial aid was provided to nearly every student through a variety of scholarships and grants, supporting the pursuit of degrees. Formal classroom instruction was provided by approximately 75 fulltime teaching faculty members, with a faculty-student ratio of approximately 1:11. To assist the instruction programs of the College and to support the academic success of all students, academic services were provided through the library, academic computing, The Powell Resource Center (for academic counseling, career services, personal counseling, skill development, testing resources, tutoring, workshops, and academic accommodations for students with documented disabilities), and the Office of the Academic Dean. Writing labs and quantitative labs were available to students on an ongoing basis. The academic programs continued to expand into the health sciences through the pursuit of a Doctor of Physical Therapy Program. International experiences for Emory & Henry students continued to increase as additional programs were added. Short-term and semester programs were made available in a wide variety of curriculums. National travel also continued to be an important part of many service-learning programs and general curriculums.

Auxiliary services were provided to all students. Over 700 students were provided housing and meals. Construction on a new co-ed dorm began during the year and is scheduled for completion very soon. The new facility will provide new housing to over 100 students. In addition, the dining facilities on campus were completely renovated and upgrades were made to the menu offerings for students. A new field house was constructed, providing better facilities for the football players and coaches, enhancing the football program of the college. This created additional space and enhanced facilities for the other sports programs. The baseball facilities were improved significantly, as well. The Mercantile continued to provide books, art and school supplies, and essential grocery and health products to students for their convenience.

Various services were provided to students through many programs and offices, including intramural sports, general athletics, the Outdoor Program, spiritual life, the Martin Brock Student Center, Admissions, Financial Aid, the Registrar, the Student Health Center, the Appalachian Center for Community Service, the Bonner program, the Centralized Student Assistance Office, and the Office of the Dean of Students. Nearly 890 students received some form of financial aid through various scholarships and grants, providing the opportunity to pursue degrees. Campus employment was made available to many students, providing financial resources and valuable work experience. Many community service opportunities were provided, including mission work and service through a Habitat for Humanity project.
