The mission of the Omohundro Institute of Early American History & Culture is to further the study, research, and publication bearing upon American history approximately to the year 1815. The Institute strives to stimulate interest in the early period of American history, encourage and assist writers and scholars in their studies and research, maintain the accepted standards of historical accuracy and integrity, and to preserve and advance understanding of the enduring contributions of the founders of the Republic.

Research Related to America's Colonial Period

Since 1943, the Institute has been active in documentary research and editing, publishing collections of manuscripts deserving circulation in print and new editions of classic works no longer available, as well as annotated editions of the papers of a number of prominent early Americans.

1680-1783. Many books are in production and copyediting, plus the Institute
continues to review numerous manuscripts and proposals.

The Institute offers one-year and two-year postdoctoral fellowships, awarded each
year to the most promising candidate in an international competition. Institute
fellows devote their time to research and writing. During this fiscal year, three
fellowships were awarded.

The Institute's editorial apprenticeship program, which graduates on the average
three to four people per year, is an integral part of the Master's and Ph.D. program

More than any other in the journal's history, the sixty-ninth volume features essays that concentrate on material objects and evidence other than written texts and documents. "The Material and Social Practices of Intellectual Work: Jonathan Edwards's Study" (October) by Wilson H. Kimnach and Kenneth P. Minkema shows how the intellectual work of this eighteenth-century theologian was grounded in and emerged from specific material and social practices. The ink he made himself, the paper he recycled, the sermons he reduced in size to fit the palm of his hand in the pulpit, the notebooks he stitched together, the interleaved Bible he created and used as a master index, the study furniture he had customized, and the books he borrowed, lent, and saw through the press—all of these things mark material experiences that helped give shape to his ideas. The Kimnach and Minkema essay gives us an embodied Edwards, an Edwards back in his study, and it helps us reimagine that study as an actual space where this master craftsman produced his works.

Three other essays focus on material objects. The January issue presents "The Plantation Hoe: The Rise and Fall of an Atlantic Commodity, 1650-1850" by Chris Evans, which argues that the hoe, usually assumed to be "a crude, archaic tool requiring no explanation" was in fact "adapted to different plantation environments and underwent successive redesigns across the seventeenth and eighteenth centuries." Making hoes "relied upon product innovation, flexible manufacturing networks, and niche marketing targeted at (and responsive to) transatlantic customers—features more commonly associated with high-end consumer goods." Catherine Cangany's "Fashioning Moccasins: Detroit, the Manufacturing Frontier, and the Empire of Consumption, 1701-1835" (April) examines "the appropriation, fabrication, distribution, marketing, and consumption of a native cultural item by nonnatives" to challenge our understanding of the frontier. We see how Detroit "reversed production, distribution, consumption, and fashionability to flow from west to

east." Another article in April, Steven C. Bullock and Sheila McIntyre's "The Handsome Tokens of a Funeral: Glove-Giving and the Large Funeral in Eighteenth-Century New England," explains the rise and fall of a prominent social practice: elites giving away large numbers of gloves at funerals "to affirm their commitment to their local communities." In addition, Glenda Goodman's essay on Indian psalmody in seventeenth-century New England and Deborah Lubken's piece on bell ringing, both published in October, present very different discussions of early American soundscapes.

The Forums and the WMQ-EMSI Workshop provoked important historiographical reflections. James H. Merrell's "Second Thoughts on Colonial Historians and American Indians" (July) surveys early Americanist scholarship written in the previous dozen years and argues that our "understanding of the Indians' experience, of their place in early America-and therefore of early America itself-is still handicapped by historians' use of an archaic, Eurocentric vocabulary." Andrew Cayton, Wendy A. Warren, Juliana Barr, Michael Witgen, and Mark Peterson respond. In "Rethinking Mercantilism: Political Economy, the British Empire, and the Atlantic World in the Seventeenth and Eighteenth Centuries" (January), Steve Pincus challenges the notion that before the era of free trade there was a European consensus about political economy holding that the world's wealth was finite and thus economic competition was a zero-sum game. Instead, Pincus claims that many Britons voiced an opposing view and that political economy was hotly debated within party politics. Forum contributors Cathy Matson, Christian J. Koot, Susan D. Amussen, Trevor Burnard, and Margaret Ellen Newell assess Pincus's argument. The July Forum entitled "Jean-Jacques Dessalines and the Haitian Revolution" includes three essays by Philippe R. Girard, Julia Gaffield, and Deborah Jenson (introduced by Laurent Dubois) that present new archival evidence that significantly revises our

understanding of Dessalines and revolutionary Haiti. In the Critical Forum in April's Reviews of Books section, five scholars engage in a dialogue with Pauline Maier about her *Ratification: The People Debate the Constitution, 1787-1788*. Terri L. Snyder's WMQ-EMSI Workshop convener's essay, "Refiguring Women in Early American History" (July), surveys work on early American women's history and the place of women as subjects in historical scholarship more broadly.

Other articles in the volume display the geographic range and methodological breadth of the early American field. Nancy E. van Deusen uncovers Spanish constructions of indigenous slave identity through court records in "Seeing Indios in Sixteenth-Century Castile" (April). In the same issue, Diana Paton examines the complex interrelationships of "Witchcraft, Poison, Law, and Atlantic Slavery" in Jamaica and Saint Domingue. In January, David E. Narrett takes us to the Spanish borderlands and Mexico with the intriguing James Wilkinson, and Farley Grubb analyzes how states redeemed the Continental dollar. In October, Jonathan P. Eacott reexamines the structure of the British Empire by focusing on the Calico Acts and Paul Kelton reenvisions the mid-eighteenth-century war for empire in North America as "The British and Indian War" by highlighting the previously neglected role of the Cherokees.

Conferences and Colloquia

Through conferences and colloquia, the Institute has played a major role since 1952 in setting new directions in early American scholarship. Conferences and colloquia stimulate research on subjects in need of renewed study and fresh approaches and bring together leading scholars to comment critically on commissioned

historiographical essays and bibliographies. The Institute colloquium met frequently during the 2011-2012 academic year, for informal discussions of scholarly work in progress.

The Institute's offered four conferences during 2011-2012. In September, the annual meeting of the British Group in Early American History took place at the University of Canterbury. William Pettigrew of that university and author of a forthcoming Institute book chaired the program committee. The conference title was "The 'Growing Daughter': Economies and Cultures in the Development of Early America." In March, The 'Political Arithmetick' of Empires in the Early Modern Atlantic World, 1500-1807," was chaired by Holly Brewer of the University of Maryland, an Institute author, and Peter Thompson of St. Cross College, University of Oxford, a former Council member. In May, the seventh William and Mary Quarterly/USC-Huntington Early Modern Studies Institute Workshop, "Early American Biographies," took place at the Huntington, with former Council member Annette Gordon-Reed, now of the Harvard Law School, as Convener. In June, the Eighteenth Annual Omohundro Institute Conference at the Huntington, was held in honor of Robert C. (Roy) Ritchie, chair of the Executive Board, who retired last year as W. M. Keck Foundation Director of Research. Council member Peter C. Mancall (USC) and his USC colleague, former Council member Carole Shammas, chaired the program committee.

St. George Tucker Law Papers

St. George Tucker: Law Reports and Selected Papers, 1782-1822, is an annotated edition of the legal manuscripts of the Virginia jurist and legal commentator best known for his 1803 edition of Blackstone's Commentaries. From the 1780's to the

1820's, Tucker served at every level of the Virginia court system and spent the last dozen years of his career as a federal judge, sitting with Chief Justice Marshall on the U.S. Circuit Court.

The body of the edition consists of Tucker's reports of some 1200 cases. These fill thirty-five manuscript notebooks covering cases in the Virginia courts, 1786-1811, which Tucker later had bound together in three volumes. Tucker also compiled three notebooks of federal cases, 1813-1822. The edition is divided into "chapters," corresponding to Tucker's numbered notebooks. The opening "chapter" is a general introduction consisting of a biographical sketch of Tucker and an extensive consideration of his career as a lawyer and judge. From matter includes, among various editorial apparatus, a description of the manuscript and its provenance and a short-title bibliography. There are three appendices: a biographical register of the bench and bar, a glossary of selected legal terms, and documents relating to the rupture between Tucker and his Court of Appeals colleague, Spencer Roane. Back matter includes tables of statutes, cases cited, and cases reported by Tucker.

Originally expected to consist of two volumes, the edition will fill three substantial volumes. As of the end of the year, the manuscript was being reviewed by the Institute's outside readers. The next step, assuming positive readers' reports, will be obtaining approval of the UNC Press Board. If all goes smoothly, publication will likely occur in the fall of 2012.
