Our drug prevention program works together to reduce substance abuse in the Brooke-Hancock area focusing on youth and families. Working with the Drug Free Community and the Substance Abuse Prevention programs, we provide community education to promote an alcohol and drug free life style. An estimated 40,000 residents have heard or seen our messages. Working with the WV Raze program for teens and tobacco cessation programs, we draw attention to the dangers of tobacco. An estimated 30,000 residence received information this year. We are involved with the National Youth Leadership Initiative which provides youth with knowledge and skills to promote significant community change. Eight youth participated in the program this year.

Our Parents as Teachers program assist parents of children, prenatal to five years of age, with early development training and tools. Our Certified Parent Educators conduct learning activities that stimulate the child's intellect, social, emotional, language and motor development. They also provide free books and developmental information along with support for the families. Approximately 65 clients are served monthly.

Our Family Resource Center opened this year. It is a safe, fun place for families to receive training and material on their children's development, on parenting skills, to participate in parent-child activities, connect with other parents or peers with similar concerns, and receive information and referrals to other community agencies and services as needed. The Center is open to all families in Hancock and Brooke counties with the focus on children aged from prenatal through college and/or employment. Our goal is to provide families with the resources they need to help their children become independent, productive adults. Approximately 180 people have visited our Center since it opened.
