We believe these are the building blocks of a good life for everyone. By making results-based investments through our Community Investment Fund, we support long-lasting measurable change in people's lives. Our efforts, magnified by others, add up to real change. Children succeed in school. Families gain financial stability. The health of our neighbors improves and, suddenly, so does our entire community. In 2011-2012, we saw a 120% return on our investment in Education, Income and Health. Our return is not measured in dollars, but in lives changed. We expected to see 59,000 people improve their lives and saw more than 71,000 people actually do so.
