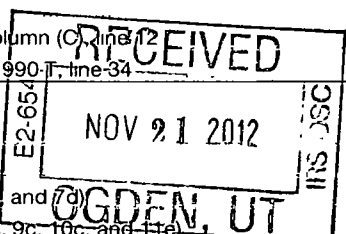

EDUCATION: IN PRIOR YEARS, THE ACHIEVING THE DREAM ("ATD") PROGRAM WAS A MAJOR REVENUE SOURCE FOR MDC. DURING 2010, MDC SPUN-OFF ATD, CREATING A NEW, INDEPENDENT, 501(C)(3) NON-PROFIT ORGANIZATION. DURING THE TRANSITION YEAR OF 2011, GRANT FUNDING THAT NORMALLY WOULD HAVE FLOWED TO MDC WAS REDIRECTED TO ATD. FOR MDC'S FISCAL YEAR ENDING JUNE 30, 2012, THERE IS NO ATD-RELATED REVENUE IN MDC'S REVENUE. HOWEVER, VIRTUALLY ALL OF MDC'S PROGRAMS HAVE AN EDUCATIONAL COMPONENT-OFTEN INVOLVING COMMUNITY COLLEGES-TO HELP TEENS, YOUNG ADULTS, AND DISPLACED WORKERS IN NEED OF RETRAINING RECEIVE THE SUPPORT THEY NEED TO ATTAIN A DEGREE OR CERTIFICATE THAT PREPARES THEM FOR A LIVING-WAGE JOB. MDC MANAGES THE DEVELOPMENTAL EDUCATION INITIATIVE, WHICH PROVIDES GRANTS TO 15 COLLEGES IN SIX STATES AND IS FOCUSED ON IDENTIFYING SUCCESSFUL

EMPLOYMENT: MDC HAS MORE THAN 40 YEARS OF EXPERIENCE IN WORKFORCE DEVELOPMENT AT THE LOCAL, STATE, REGIONAL, AND NATIONAL LEVELS, AND ITS CONSISTENT GOAL HAS BEEN TO REMOVE BARRIERS BETWEEN PEOPLE AND GOOD JOBS.
