Building and sell homes to families in need. The Organization completed the construction and sale of 17 houses during the year ended June 30, 2012. Persons served totaled 23 adults and 32 children.

Work in progress at June 30, 2012 included 15 houses.

Included in the 17 households were the following: 3 families in the very low income category (&lt;51% AMI), 14 families in the low income category (51-65% AMI), 11 single parent families, 4 ethnic minority families, 2 elderly individuals, 3 disabled individuals and 6 families with English as a second language.

Preserve existing homes for families in need. The Organization completed the repair of 16 homes including 6 disabled persons and 7 ethnic minority families.

of employees. Annually, compensation for all employees is reviewed by the executive management team. Raises are  
generally awarded based on cost of living, but department heads are allowed to spread raises unevenly through their  
department bases upon merit, within strict limits. The compensation of the Executive Director is included in the  
compensation plan and the annual review. Wage and salary increases are presented in total and by department to the  
Board of Directors for approval along with the annual budget. Periodically, the compensation plan is tested against  
information from a regional service bureau, to ensure that wages and salaries are reasonable for the Western North  
Carolina area. A report of this test is reviewed by the Board of Directors. The last test was made during the year ended  
June 30, 2007.
