Crisis Assistance Network (CAN) provides financial help, groceries, and clothing to individuals in need. Crisis Intervention Program (CIP) is a Low-income Home Energy Assistance government program (CFDA 93.568), that assists with heating and cooling disbursements of vouchers. During the year ended 6/30/12, the organization provided \$1,107,793 in direct financial assistance impacting 12,299 individuals and distributed 364,776 pounds of groceries to 9,163 families that impacted 20,499 individuals.

Soup Kitchen provides hot meals for needy. During the year ended 6/30/12, 90,990 prepared meals were served in the Soup Kitchen and the Shelter.

Overnight Shelter for homeless individuals. During the year ended 6/30/12, the organization provided 18,105 overnights to 540 individuals. New Tomorrows had 116 participants.
