We averaged over 80 participants in the Purusha program in the USA focusing on the development of full human potential by enlivening the entire brain through the practice of the TM and TM-Sidhi programs. The group experienced more and clearer experiences of higher states of consciousness through this practice of Maharishi's Vedic Science. Located on the campus of Maharishi University of Management and in Maharishi Vedic City in Iowa, and in a new facility in West Virginia, these participants contributed to both the coherence creating group assembled in Iowa for the Invincible America Course, and National Super Radiance thus adding to the coherence created for both the United States and the World. By enlivening collective consciousness the coherence creating groups help the unfoldment of world peace and harmony. MPP also donated \$275,000 to the Global Capital to help with the construction of a new home for MPP in West Virginia. This donation is listed above as part of Expenses. MPP also relocated 55 Purusha from the Maharishi Vedic City and MUM locations to our new facility being completed in West Virginia. Once the facility is finished this year all Purusha currently located in Iowa will be located there. With about 80 participants located in West Virginia a strong influence of coherence will envelope the Nations Capital in Washington DC, which is only two hours away. This influence of coherence will help our Nations Leaders make decisions more in tune with Natural Law.

We averaged 70 participants in the Purusha program in Uttar Kashi in the mountains of India. These participants focused on unfolding full human potential through the practice of Maharishi's Vedic Science and enjoyed deeper and more frequent experiences of higher states of consciousness. Located in an ideal setting for focusing on the rapid development of consciousness these participants dedicate themselves to becoming fully enlightened so they can inspire others to unfold full human potential and live totally stress free, blissful and productive lives supported by all the laws of nature.

We were very pleased to be able to support our affiliated Indian organization in India which focuses on training Maharishi Vedic Pundits as Purusha who practice the techniques and programs of His Holiness Maharishi Mahesh Yogi to unfold their full human potential through the rapid development of consciousness. These Vedic Pundits are trained to perform traditional Vedic ceremonies to enliven the total support of Natural Law in individuals, and the environment. Our Indian affiliate is creating a home in India for thousands of these Pundits who, through their collective practice of Maharishi's TM and TM-Sidhi programs, will generate a tremendous influence of coherence and peace in the collective consciousness of the entire world. The goal is to generate a strong enough influence in collective consciousness to ensure world peace and harmony for all countries of the world.
