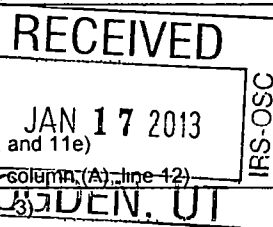
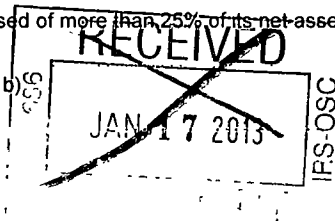

THE "CHILD CARE RESOURCE AND REFERRAL" PROGRAM PROVIDES PARENTS WITH INFORMATION REGARDING CHILD CARE OPTIONS, COORDINATES AND CONDUCTS TRAININGS FOR CHILD CARE PROVIDERS AND PARENTS, PROVIDES ON SITE AND OTHER TECHNICAL ASSISTANCE TO CHILD CARE FACILITIES IN ORDER TO MAINTAIN OR IMPROVE QUALITY, DISTRIBUTES PROVIDER NEWSLETTERS, AND PROMOTES COMMUNITY AWARENESS OF CHILD CARE ISSUES. OTHER SERVICES INCLUDE A RESOURCE LENDING LIBRARY PROVIDER APPRECIATION BANQUET, CHILD CARE CONFERENCE, SCHOOL AGE SERVICES, PARTICIPATION IN COMMUNITY EVENTS AND PROFESSIONAL DEVELOPMENT PLANNING. 38 TRAINING SESSIONS WERE HELD, WITH 454 CHILD CARE PROVIDERS FROM 87 FACILITIES PARTICIPATING IN THE TRAINING SESSIONS. THE ORGANIZATION ALSO RESPONDED TO 418 ON SITE TECHNICAL ASSISTANCE CALLS.

PREKINDERGARTEN IS A RESEARCH PROVEN STRATEGY FOR SCHOOL READINESS. NCPK PROVIDES EDUCATED TEACHERS, SMALL CLASS SIZES AND LOW TEACHER-CHILD RATIOS, RESEARCH BASED COMPREHENSIVE CURRICULA, AND A FOCUS ON THE WHOLE CHILD AND FAMILY. A TOTAL OF 867 CHILDREN WERE SERVED DURING THE FISCAL YEAR.

THE YOUNG WOMEN EFFECTIVELY USE THESE SERVICES IN A COORDINATED WAY SO THEY SUCCESSFULLY REACH THEIR GOALS WITH HEALTH MAINTENANCE, PARENTING SKILLS AND SELF SUFFICIENCY AND DELAY SUBSEQUENT UNPLANNED PREGNANCIES WHILE THEY WORK ON THEIR GOALS. OTHER SERVICES TO PARTICIPANTS INCLUDE MENTORSHIP, YOUTH MEDIA PROJECTS, FOCUS GROUPS AND A VARIETY OF EDUCATIONAL SESSIONS.
