A RESOURCE FOR ITS 209 COUNCILS THROUGHOUT NORTH AMERICA, GIRLS ON THE RUN INTERNATIONAL CONTINUES TO SUPPORT AND TRAIN COUNCILS TO DELIVER THE GIRLS ON THE RUN PROGRAM IN 6,171 SITES IN 47 STATES AND CANADA. THIS CURRICULUM ADDRESSES CHALLENGES ADOLESCENT GIRLS FACE AND PROVIDES TOOLS TO ENCOURAGE CRITICAL THINKING. IT IS A 12-WEEK, 24-LESSON PROGRAM AND TRAINING PLAN THAT CULMINATES IN A 5K EVENT. THE CURRICULA IS SPLIT INTO THREE DISTINCT SECTIONS THAT BUILD UPON EACH OTHER: SELF, TEAM, AND COMMUNITY AND ADDRESSES TOPICS SUCH AS HOLISTIC HEALTH, CONFIDENCE, BULLYING, HEALTHY HABITS, AND COMMUNITY SERVICE PROJECTS.
