THE PIONEER SCHOLARS PROGRAM SERVES 1ST-8TH GRADE ACADEMICALLY FOCUSED LOW-INCOME STUDENTS. THIS OUT-OF-SCHOOL PROGRAM DEVELOPS A STRONG FOUNDATION OF ACADEMIC SKILLS IN ELEMENTARY AND MIDDLE SCHOOL STUDENTS TO ENSURE READINESS FOR SUCCESS IN A COLLEGE-PREPATORY HIGH SCHOOL CURRICULUM. IN 2011-2012 TEACHERS, WITH THE SUPPORT OF VOLUNTEERS, IMPLEMENTED INDIVIDUALIZED CURRICULUM FOR 72 STUDENTS. THESE STUDENTS ATTENDED 158 DAYS DURING THE SCHOOL YEAR FOR 2.5 HOURS EACH DAY, AS WELL AS, 24 DAYS DURING THE SUMMER FOR 4 HOURS EACH DAY. IN ADDITION TO THIS, FAMILIES PARTICIPATED IN ADDITIONAL ENRICHMENT ACTIVITIES AND PARENT EMPOWERMENT SESSIONS. STUDENT OUTCOMES WERE MEASURED USING THE WOODCOCK-JOHNSON TESTS OF ACADEMIC ACHIEVEMENT, STUDENT REPORT CARDS, HARTER SELF-PERCEPTION INDEX, AND STAKEHOLDER SURVEYS. ACCORDING TO RTI INTERNATIONAL, THE PIONEER SCHOLARS PROGRAM CAUSED IMPROVEMENT IN STUDENTS' READING AND MATH SKILLS.

THE SCHOLARS TO COLLEGE PROGRAM SERVES ACADEMICALLY FOCUSED, LOW-INCOME HIGH SCHOOL STUDENTS. THIS OUT-OF-SCHOOL PROGRAM ENSURES THAT HIGH SCHOOL STUDENTS MAXIMIZE THEIR POTENTIAL TO BECOME WELL-PREPARED, COLLEGE BOUND STUDENTS AS GRADUATING SENIORS. IN 2011-2012 EDUCATORS PROVIDED INDIVIDUALIZED ACADEMIC, COLLEGE, AND CAREER GUIDANCE TO 50 STUDENTS. THESE STUDENTS PARTICIPATED IN 39 CURRICULUM NIGHT SESSIONS AS WELL AS A 20 HOUR SUMMER SKILLS "BOOT CAMP". IN ADDITION, EACH STUDENT RECEIVED 50 HOURS OF INDIVIDUALIZED SUPPORT OUTSIDE THE CENTER, AS WELL AS PARTICIPATED IN CENTER-FACILITATED ENRICHMENT ACTIVITIES AND PARENT EMPOWERMENT SESSIONS. STUDENT OUTCOMES WERE MEASURED USING REPORT CARDS, STANDARDIZED TEST SCORES, THE FREDERICKS SCHOOL ENGAGEMENT SCALE, AND STAKEHOLDER SURVEYS. 2012 MARKED THE FIRST GRADUATING CLASS FOR THE SCHOLARS TO COLLEGE PROGRAM WITH 9 SENIORS GRADUATING AND SET TO ATTEND COLLEGE IN 2012-13.

IN ADDITION TO THE K TO COLLEGE MODEL, THE CENTER FACILITATED THE WORK OF 66 OTHER NONPROFITS AND ORGANIZATIONS THAT UTILIZED THE MULTIPURPOSE ROOMS, GYMNASIUM, AND STAGE TO FURTHER THEIR IMPACT ON DURHAM. THESE PARTNERS USED THE CENTER TO DIRECTLY SERVE FAMILIES, COORDINATE THEIR OWN WORK, AND HOST SPECIAL EVENTS. OVER 1,500 STUDENTS AND COMMUNITY MEMBERS USED THE FACILITY MONTHLY.
