THE ASSOCIATIONS FLAGSHIP PROGRAM, LIVING WELL WITH PARTIAL VISION, PROVIDES IN-HOME VISION REHABILITATION TREATMENT FOR INDIVIDUALS IN COASTAL SOUTH CAROLINA AND IS THE ONLY PROGRAM OF ITS KIND IN THE STATE. TRAINED OCCUPATIONAL THERAPISTS TREAT PATIENTS REFERRED BY EYE CARE PROFESSIONALS TO LIVE SAFELY AND INDEPENDENTLY IN THEIR HOMES DESPITE SEVERE VISION LOSS. THIS MEDICARE-APPROVED PROGRAM WAS BEGUN IN 2002 AND MORE THAN 150 PATIENTS ARE TREATED EACH YEAR WITH OVER 90 SHOWING IMPROVEMENT IN SELF-CARE AND HOME-CARE MANAGEMENT AND IN USING ASSISTIVE DEVICES SUCH AS MAGNIFIERS.

GRADUATES HAVE LEARNED TO TYPE TEN WORDS PER MINUTE, ARE ABLE TO SEARCH THE INTERNET AND CAN SEND GRADUATES. THIRTY PARTICIPATED IN THE PROGRAM DURING THE CURRENT FISCAL YEAR.
