


SUPPORT OF UNIVERSITY OF SOUTH CAROLINA SCHOOL OF MEDICINE AND ITS CLINICAL FACILITIES. ACADEMIC ENHANCEMENT FUNDS ARE PROVIDED FROM 7% OF CLINICAL PATIENT BILLINGS AND CONTRACT REVENUES. THESE FUNDS ARE PROVIDED TO THE MEDICAL SCHOOL AND THE CLINICAL FACILITIES FOR A VARIETY OF PROJECTS AND EXPENSE REIMBURSEMENTS THAT WOULD OTHERWISE BE PAID WITH APPROPRIATED STATE FUNDS OR NOT PURCHASED AT ALL. AN OPERATIONS SUBFUND, PRESENTLY 4% OF REVENUES, IS USED TO MITIGATE THE EFFECTS OF MANDATED APPROPRIATED FUND BUDGET REDUCTIONS AT THE SCHOOL OF MEDICINE. A CLINICAL SUPPORT SERVICES SUBFUND, PRESENTLY 1% OF REVENUE, IS USED TO PROVIDE SERVICES COMMON TO ALL THE CLINICS, SUCH AS MARKETING.
