



THE MINISTRY PROVIDED SHELTER FOR NINE UNWED MOTHERS DURING THE TAX PERIOD. EXPENSES FOR THIS ITEM INCLUDE HOUSE PARENTS SALARY, FOOD, AND NECESSARY SUPPLIES. THE MINISTRY ALSO PROVIDES VARIOUS TRAINING PROGRAMS TO PREPARE EXPECTANT MOTHERS FOR PARENTHOOD. MOTHERS RECEIVE BIBLICAL BASED MENTORING TO HELP THEM WORK THROUGH THEIR CRISIS SITUATIONS, AND TO HELP THEM DECIDE WHETHER TO PARENT OR PLACE THEIR BABIES FOR ADOPTION. FAMILY MEMBERS ALSO RECEIVE HELP THROUGH GROUP SESSIONS AND SUPPORT MEETINGS WITH THE STAFF.
