Instruction - The College is built on the belief that academic disciplines in the liberal arts can be taught within the context of the Christian faith in order to provide young people with a high quality education which emphasizes what matters most principles, ideals, ethics, morals, and values. With an enrollment of 922 current students, Truett-McConnell College has increased its enrollment by 77% since 2009. Also, over the past two years, the school has obtained a faculty of which more than 62 percent hold doctorates in their respective fields. The College offers thirty seven four-year programs of study in majors in business, humanities, Christian studies, education, history, music, and interdisciplinary studies. Truett Online, a program that offers students the opportunity to earn a degree completely online, began in the spring of 2009 and now offers students the opportunity to earn a degree in business or Christian studies. Truett Online has specifically reached out to bi-vocational pastors, as well as laity, to offer an opportunity for them to continue their education. Truett-McConnell College is accredited by the Commission on Colleges of the Southern Association of Colleges and Schools.
