Instruction - Rabun Gap - Nacoochee School is a 100-plus year old independent boarding and day school providing co-education college-preparatory in grades six through twelve that has a covenant relationship with the Presbyterian Church Rabun Gap - Nacoochee School (RGNS) educated approximately 350 students from 17 countries and 10 states for the current fiscal year with an average class size of 11 The Middle School had an enrollment of approximately 85 boys and girls International students comprise approximately 25 percent of the student body The faculty averages 14 years of teaching experience, with an average of 10 years at RGNS Of the 45 classroom teachers and 10 residential faculty, approximately 50 percent hold graduate degrees or higher Advanced Placement (AP) courses offered in all academic departments with 79 students enrolled in an AP course and 77 percent of AP candidates received a score of 3 or higher, making them eligible to receive college credit for their work With 24 clubs and student organizations, students participate in a wide range of activities The international students have a diverse range of activities that include all types of generational contribution
