Conflict of Interest - Procedures

Cumberland Community Foundation, Inc. requires that its staff members (upon employment), board of directors (annually) and individuals serving on standing committees (annually) sign the Foundation's *Conflict Of Interest Statement* and *Conflict of Interest Disclosure Form*.

The Executive Director and Board President will review the disclosure forms and develop a resolution to any conflict that represents a problem that cannot be satisfied by disclosure. A scanned copy of the member's *Conflict Of Interest Statement* and *Conflict of Interest Disclosure Form* will be saved in the member's FIMS profile folder. The original will be saved in the member's board, volunteer, or personnel file.

In all matters that come before the staff, board of directors, or standing committee for a vote that may favorably impact his/her financial interests, or the private interests of others with whom he/she has a financial relationship, he/she will reveal that relationship and abstain from a vote in the matter. At the beginning of every meeting, participants will be asked for any disclosures needed.

When a conflict of interest arises, or when a potential conflict of interest emerges--

- ***If the conflict occurs during a meeting***, he/she will disclose that conflict, or potential conflict, to those present and offer to leave the meeting during discussion. The disclosure and nature of the conflict will be recorded in the minutes. The member having disclosed the conflict will not vote on the item up for vote and said abstention will be recorded in the minutes.

Depending on the nature of the conflict, the acting committee chair will decide if the member --

1. will remain during discussion without participation
2. will remain during discussion and contribute with details known
3. will be excused from the meeting during that part of the meeting where discussion or decisions may be influenced.

Any member of the committee (or board) may question the decision and request a vote, which will be recorded in the minutes.

- ***If the conflict of interest arises outside of a meeting***, he/she will disclose that conflict, or potential conflict, to the director of Cumberland Community Foundation, Inc. or to the President of its board of directors and seek a resolution of that issue. The director and the President will work together to develop the resolution.

The conflict and its resolution will be reported at the next meeting of the Executive Committee, or before in writing to the Executive Committee, if time is of the essence. If the director &/or the President are involved in the conflict disclosed, the Vice President (and Secretary or Immediate Past President, as needed) will step into that person's role in developing the resolution.

In addition to the above procedure, all Scholarship Selection Committees will complete the *Certification Statement* upon recommending the students receiving awards. (Example Attached.)
