THE OPEN DOOR FREE CLINIC PROVIDES PRIMARY HEALTH CARE AND PRESCRIPTION MEDICATIONS IN A MEDICAL HOME MODEL TO A PATIENT BASE OF 5,000 UNINSURED, LOW-INCOME ADULTS.
