During the 2011/2012 school year, we served 46 children with special needs in classrooms with approximately 550 peer students.

Therapy - ALC offers outpatient and inclusive speech and occupational therapy services by licensed therapists. These services are available to children from birth through age 6 who require these services. We served 4 children during the course of the year.
