THERE ARE CURRENTLY MORE THAN 115,000 PATIENTS AWAITING TRANSPLANTS IN THE UNITED STATES. WHILE 90 PERCENT OF AMERICANS SAY THAT THEY SUPPORT ORGAN DONATION, ONLY 30 PERCENT OF LICENSED DRIVERS HAVE OFFICIALLY REGISTERED AS DONORS.
