IN 2010, THE SUPPORT CENTER LAUNCHED ITS SMALL BUSINESS REVOLVING LOAN FUND PROGRAM (SBRFLF), TARGETING UNDERSERVED COMMUNITIES AND POPULATIONS THAT FIND IT DIFFICULT TO ACCESS CAPITAL. THE SBRFLF PROGRAM IS AN EXTENSION OF THE SUPPORT CENTER'S STATE ECONOMIC DEVELOPMENT ASSISTANCE LENDING PROGRAM THAT ENABES CDCU'S TO ENGAGE IN SMALL BUSINESS LENDING. OTHER FUNDING PROGRAMS INCLUDE CAPACITY GRANT ASSISTANCE, SECONDARY CAPITAL INFUSIONS, AND GENERAL DEPOSITS WITH CDCU'S. THE SUPPORT CENTER ALSO OFFERS TECHNICAL ASSISTANCE IN AREAS SUCH AS COMPLIANCE AND REGULATION, MARKETING AND GRANT WRITING, AND ASSESSMENT OF HOUSING PROGRAMS AND COORDINATION OF HOUSING FINANCING.
