Supportive Housing Communities, Inc. owns and operates McCreesh Place, a 91-unit, permanent supportive housing apartment community. In FY 2011-2012, McCreesh Place provided affordable housing and support services for 109 disabled men overcoming homelessness for a total of 39,387 days of housing. Tenants pay 30% of their income in rent. There were 3,716 service planning and support contacts, 1,704 resident crisis intervention contacts, and 629 on-site community and group meetings coordinated and facilitated by staff.
