GateKey provides funds for tuition and a book allowance with the option to attend either Georgia Highlands College or Chattahoochee Technical College. Students may be nominated for a GateKey Scholarship in grades 6 through 11, and if selected, must maintain at least a "C" average in all classes, complete school work, and remain crime and drug free. The program currently supports 66 students.

Classroom Excellence Mini-Grants - Awards money for instructional enhancement to teachers who submit creative ideas through a grant process.
