The university educates over 1,400 students with satellite locations in Peachtree City and Savannah, GA.

During the tax period ending June 30, 2012, the University changed its name to Point University, Inc.

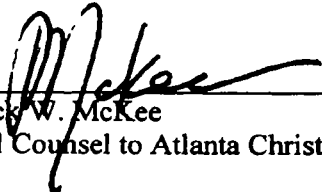
