These students are identified through local organizations (Overtown Youth Center, Breakthrough Miami, etc.) as benefiting from a Cushman education. Not only are the children impacted, but also their families. Cushman Cares is a parent service based group. Cushman Cares collects items (not money) and gives back to the community. The different service projects include: a canned food drive for Thanksgiving (donations go to The Community Partnership for the Homeless) a holiday toy drive for Head Start, clothing and shoe for Haiti, relief for Japan, book drive, and Blood Drive.
