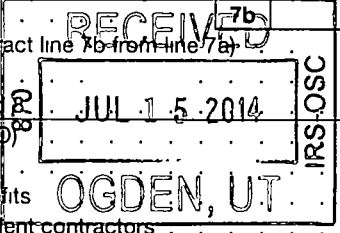

Dial-A-Ride - \$500 - Dial-A-Ride is a service provided by the Beaches Council on Aging (EIN - 59-2085522) to transport infirmed+handicapped individuals to the store, doctor's appointments, pharmacy, etc. Dial-A-Ride has been in need of financial assistance and the Beaches Community Kitchen voted to make a contribution to their ministry, which is much in keeping with the Kitchen's ministry.

Mission House - \$1,000 Mission House (EIN 59-3376704) provides Beaches Community Kitchen with a permanent place to store food+freezers and a central place for preparation and delivery of meals at no charge to Beaches Community Kitchen. The Board of BCK voted to make contributions to Mission House for this service.

Administration - \$280 - bank checks, P.O. Box rental, State of Florida annual filing, Sam's Club membership.

Food/Paper Products - \$6,233 - all food + paper products purchased to provide meals for those served by BCK.
