ROSM was awarded Kentucky HEARTH grants, which originated through the U.S. Department of Housing and Urban Development. ROSM procedures track grant money through a

database program listing the client, number of family members, type of assistance, amount of assistance, and date the assistance was paid. The client is never given the funds to pay for

a service. ROSM directly pays the service provider. Each month, the database is balanced to the amount of the grant that was disbursed for the month. In addition to our records, every

client receiving HEARTH grant funds was entered into a nationwide system called Homeless Management Information System (HMIS). Staff was trained to operate this system as well as

how to report through HMIS. ROSM's score throughout the reporting of the HEARTH grant from the Kentucky Housing Corporation, was 100%.

When an application is received for emergency assistance, the income and expense information for the client is verified to determine the need. If the client has no other resources

available to assist him/her, ROSM will make the payment to the service provider. The primary goals is to prevent homelessness. Emergency rental payments are made to prevent evictions

and, in most cases, the client may lose housing if their utilities are disconnected. Medical considerations are made for life sustaining medications and controlled substances are never

funded by our organization.
