The President is offered a multi-year contract which outlines base salary, variable pay, benefits and other perquisites. This total compensation package is benchmarked with other land grant institutions with academic medical centers.

Other University Executives

The university employs executives and athletic coaches in non-graded exempt positions. Other than the President, these executives/coaches are presented with an offer letter that outlines their base salary, variable pay (if applicable) and perquisites. Employee benefits other than retirement contributions are offered at the same level as staff employees. Retirement contributions by the institution for senior executives may be at a higher level (e.g. 15% employer contribution) for some executives. Base salaries and variable pay are benchmarked with the universities' benchmark institutions, in addition to regional and national health care and business entities. Total compensation offered to these executive individuals and coaches is approved by the President of the university or his designee, Athletics Director if coach compensation is less than \$75,000.
