AS PART OF THE HEADMASTER'S JOB DUTIES, THE CLUBS ARE USED FOR DONOR CULTIVATION. A PORTION OF THE CLUB DUES ARE CONSIDERED TAXABLE TO THE EXTENT THAT THE MEMBERSHIPS ARE USED FOR PERSONAL USE. RELATIVE TO THE RESIDENCE PROVIDED TO THE HEADMASTER, THE SCHOOL PROVIDES CERTAIN PERSONAL SERVICES FOR THE MAINTENANCE AND CARE OF THE RESIDENCE, SUCH AS CLEANING, LANDSCAPING, ETC.
