Middle Tennessee Medical Center Foundation ("Foundation") provided grants to Middle Tennessee Medical Center ("MTMC") for the purchase of the new facility. Foundation awarded grants to MTMC for bioterrorism and pandemic flu management preparedness, salary and operating expense reimbursement for the Dispensary of Hope, mobile health unit expense reimbursement, conference and education expense reimbursement, and new facility construction.

4b (Code) (Expenses \$ 15,651. Including grants of \$ 15,651.) (Revenue \$)

Provided assistance to 70 employees by assisting with food cost, rent/mortgage payments, utility payments, car repairs, legal fees, insurance expense, property taxes, etc. Educational grants were provided to 2 MTMC associates and 2 nursing scholarships were also granted MTMC associates. In total 74 MTMC associates were granted assistance from the MTMC Foundation.

Foundation provided grants to help with indigent families' expenses as well as grants to pay for indigent patient mammograms (Approx. 330 mammograms at \$140 per). Foundation provided grants to patients of Lymphoma compression garments for treatment.

Pursuant to the provisions of Section 48-304 of the Tennessee General Corporation Act, the undersigned Corporation, not for profit, adopts the following Charter:

PART 1

1. The name of the Corporation is MIDDLE TENNESSEE MEDICAL CENTER DEVELOPMENT FOUNDATION.

2. The duration of the Corporation is perpetual.

3. The address of the principal office of the Corporation is 432 North University Street, Murfreesboro, Rutherford County, Tennessee 37130.

4. The Corporation is not for profit.

5. The purposes for which this Corporation is formed are

A. To receive, hold, care for, invest in, and operate real and personal property.

B. To use and distribute, from time to time, all of the income and/or principal, which it shall receive in gifts, bequests, devises, purchases, or otherwise, for the support and benefit of the charitable, educational, scientific, and building expansion efforts of Middle Tennessee Medical Center, Incorporated, such use and distribution to be subject to concurrence by the Board of Directors of Middle Tennessee Medical Center, Inc.

C. To encourage individuals and others to make provision for the Medical Center in their Wills or other legal instruments.

D. To foster and fund any activity that will benefit the Medical Center and its patients and staff consistent with the provisions hereof.

Above said purposes to be accomplished in a manner consistent with applicable and existing Laws of the State of Tennessee and the United States Internal Revenue Code and those which may hereafter be enacted.

6. This Corporation is to have no members.

7. The Corporation shall issue no shares of stock, shall divide no dividends or profits among its Trustees or Officers, and shall have no dues. Any profits or earnings shall be used exclusively for the purposes of the Foundation herein set forth. In the event of dissolution of the Foundation, all assets of the Foundation shall be vested in Middle Tennessee Medical Center, Inc., immediately upon such dissolution, which assets shall be used by the Medical Center in accordance with the stated purposes of the Foundation.

8. The general powers of the Corporation shall be:

A. To sue and be sued in the name of the Corporation.

B. To have and use a common seal, which it may alter at pleasure; if no common seal, then the signature in the name of the Corporation by a duly authorized Officer shall be legal and binding.

C. To have the power to receive property, real, personal, or mixed, by purchase, gift, devise, or bequest, sell the same and apply the proceeds to the promotion of the objectives for which it is created, or hold any such property and apply the income and profits to such objectives.

Gifts may be made to the Corporation

... By cash, by single gift, or on an annual basis for a specified number of years.

... By transfer of stock or other personal or real property of value.

... By individuals making the Corporation beneficiary under life insurance policies on the life or lives of interested individuals.

G. Until otherwise determined, the program may be administered as set forth in the Bylaws.

11. No substantial part of the activities of this Foundation shall be the carrying on of propaganda, or otherwise attempting to influence legislation; and this association shall not participate in, or intervene in, any political campaign on behalf of any candidate for public office.
